Dear Friends,

Suzan-Lori Parks is one of our greatest living playwrights,

and this theater season showcases her work in astonishing fashion. From the 20th anniversary revival of Topdog/Underdog, which played on Broadway in Kenny Leon's pitchperfect production, to the world premiere of Sally and Tom, a co-production of the Guthrie and The Public Theater, which opened in Minneapolis this past fall, to the new musical adaptation of The Harder They Come, which just premiered here at The Public, SLP's work has been visible on a grand scale across the country.

But here, tonight, in Joe's Pub, we are privileged to present SLP's work in a way it has never been seen before. This is her journal of the first year of the pandemic, written as a disciplined writing practice of one play a day, **recording both her personal journey** and the journey of our country.

And she performs in it as well, playing herself, The Writer.

Never has she been more vulnerable and personal; **never have we had such an extraordinary gift into her creative brain.** Shakespeare called playwrights "the abstract and brief chronicles of the time." Suzan-Lori has shown the truth of that in an incandescent way.

Thanks to Niegel Smith, our old friend who has done such a beautiful job directing this; thanks to Mandy Hackett and Jesse Alick, who have lent dramaturgical expertise and vision to the show; thanks to Alex Knowlton and the Joe's Pub team, who have been indispensable partners; and thanks to this amazing group of actors who are, as Hamlet said, "showing the age its form and pressure."

THE PUBLIC THEATER continues the work of its visionary founder Joe Papp as a civic institution engaging, both on stage and off, with some of the most important ideas and social issues of today. Conceived over 60 years ago as one of the nation's first nonprofit theatres, The Public has long operated on the principles that theatre is an essential cultural force and that art and culture belong to everyone. Under the leadership of Artistic Director Oskar Eustis and Executive Director Patrick Willingham, The Public's wide breadth of programming includes an annual season of new work at its landmark home at Astor Place, Free Shakespeare in the Park at The Delacorte Theater in Central Park, the Mobile Unit touring throughout New York City's five boroughs, Public Forum, Under the Radar, Public Lab, Public Works, Public Shakespeare Initiative and Joe's Pub. Since premiering Hair in 1967, The Public continues to create the canon of American theatre and is currently represented on Broadway by the Tony Award-winning musical Hamilton by Lin-Manuel Miranda and the Pulitzer Prize-winning play Fat Ham by James Ijames. Their programs and productions can also be seen regionally across the country and around the world. 





During lockdown, I feel like we all longed for that. And I also wrote songs, to

accompany the plays, because singing with others creates magic. These plays and songs are meant to give us some tools we need to process both what we've been through and what we're still going through now.

Shucked's Small-Town Sweetheart

Caroline Innerbichler is making her Broadway debut playing an atypical ingénue in *Shucked*.

aroline Innerbichler knows how to let the sunshine in, lyrically and energetically. As the young actor prepares to make her Broadway debut in *Shucked*, she tells Playbill that she wants those who attend the show to experience joy. The musical comedy is sure to lift audiences' spirits with a collection of corny jokes (and we don't mean that figuratively).

Shucked follows Maizy (Innerbichler), a resident of Cobb County, where growing corn is the townspeople's livelihood. When farming troubles threaten their way of life, Maizy must travel outside the town's limits and find help. After having played Anna on the *Frozen* national tour, Innerbichler knows something about feel-good musicals, and she says *Shucked* is exactly the joyful piece audiences need right now.

"Maizy is not your typical young ingénue," Innerbichler says. "The thing I love about her is that she is flawed. She's not perfect. And I find that a lot of her quirks are some of the things that end up helping her in the end. It feels really good to play [Maizy] because everybody could use a little looking on the bright side."

Shucked began previews March 8 at the Nederlander Theatre, with opening night on April 4. The company includes Alex Newell, John Behlmann, and Grey Henson. Shucked features music and lyrics by songwriters Brandy Clark and Shane McAnally, a book by Robert Horn, and direction by Jack O'Brien. Innerbichler visited the Playbill team for an exclusive performance of her "I want" song in the show: "Walls." The number takes place toward the beginning of the musical, when the corn crops are threatened by disease and Maizy recognizes her community's live-lihood is at stake. In order to save the town, she realizes that they will have to change their ways.

"[During 'Walls'], Maizy is thinking about why it's so hard for them to ask for help, and why it is so hard to ask for help in general. Why does our pride get in the way of us improving our lives, or solving our problems? It shows what a small-town mentality can do on the negative end," Innerbichler says.

The song's lyrics echo her sentiment: "Why build walls around our homes, around our hearts?...With a little hope and a little help, maybe we just might save ourselves." The score's country twang and Innerbichler's radiant presence as Maizy create a hopeful ballad that will charm audiences, and maybe inspire them to ask for help in their own lives.

"I want people to laugh again. There's a lot of negativity in the world," Innerbichler says. "We need a moment to relax and laugh together as a community. I think theatre serves us so well as people that need to heal."
