# A LOVE NOTE

When we reach toward access that is creative and collaborative and experimental, we imagine

**Ourselves into the future.** Access takes forethought and innovation and labor; it requires strategy and resilience through access conflicts and clashes; it asks us to communicate and to take risks. When tension arises—and in any complex, cross-disability space, it will—we have the choice to gravitate toward the tension and get curious, or to leave people behind. DARK DISABLED STORIES' team of creatives and dreamers has tried to prioritize the disability community at every turn to move toward an expansive practice of care.

We invite you to experience a version of performance where we consider a wider range of the human experience than is customary for the theater world. We have collaborated across language, using spoken English, written English, and American Sign Language in the rehearsal room, performance, and virtual space. We have engaged with a range of embodiments of disability and access needs in the process, in the audience, and on the stage. We have landed on an expression of access that is integrated and smooth, but also transparent and present and loud.

Access is not an add-on to the show—it is the show.

The transparency is intentional. Through open captions, open audio description, artistic sign language performance, and content that does not shy away from messy human complexity, the audience cannot help but be "in" on what accessible theatre can—and should—be. We bring you into these aspects that are often hidden or reserved for certain people with certain impairments because we want to celebrate the disability community and we want you to join us.

And yet. This is not a blueprint for how to "do access" correctly. A part of the daunting beauty of access is that it is ongoing. We never arrive at full access nor cross a finish line. We hope you experience this show as part of an ongoing exploration and hold it with you as you navigate the world a little differently. There are an infinite amount of manifestations of access in the disabled future, and **this is one still-imperfect, yet hopeful, version—one glimpse into what is possible.**

Free Shakespeare in the Park at The Delacorte Theater in Central Park, the Mobile Unit touring throughout New York City's five boroughs, Public Forum, Under the Radar, Public Lab, Public Works, Public Shakespeare Initiative and Joe's Pub. Since premiering Hair in 1967, The Public continues to create the canon of American theatre and is currently represented on Broadway by the Tony Awardwinning musical *Hamilton* by Lin-Manuel Miranda.
